Elements of the CEP

Introduction:

- What is classroom management (CM)?
- Why is it important to have a plan for CM?
- What are the elements of good classroom management?

Explanation of Plan:

- How do you plan to organize your class using the elements of good classroom management?
- What is your ideal environment lay-out and how does your design connect to your plan (a visual representation of your ideal room arrangement)?
- Who has had an influence on your plan (class text/professor, mentor, guest speakers, observation, supervisor)?
- How have your beliefs about classroom management developed or changed?
- What challenges do you foresee in implementing you plan?
(Reference textbook or other materials as needed.)

Summary:

- How does this project relate to the Danielson Model of Teacher Evaluation?
- What are some benefits of this project to you as an emerging professional?

References: Use if you quote anyone in your paper or if you borrow an idea from something that you have read besides our textbook.

Formatting and Editing:

- Use APA style for all pages.
- Number your pages.
- Write in an academic voice.
- Practice smart editing and coherent logic in your writing style.
